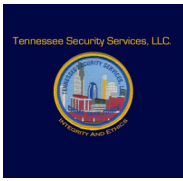

TSS CLIENT SERVICE AGREEMENT FORM (Part 3 of 4)

Venue:

The duties and obligations of the parties to this Agreement can or will be performed in whole or in part, in Davidson County, Tennessee or State of Tennessee. The parties agree that although there may be other venues that are proper under applicable law, the courts of Davidson County, Tennessee is the proper venue for the resolution of any dispute relating to or arising out of this Agreement.

Applicable Law; Construction:

This Agreement will be governed by and construed in accordance with the laws of the State of Tennessee, without regard to any conflict of laws rule or principle that might refer the governance or construction of this agreement to the laws of another jurisdiction. This Agreement will at all times and in all events be construed as a whole, according to its fair meaning, and not strictly for or against any party.

Counterparts:

This Agreement may be executed in counterparts, with the same effect as if both parties had signed the same document. All such counterparts will be deemed an original, will be construed together and will constitute one and the same instrument.

Number and Gender of Words:

Except where the context indicates otherwise, words in singular number will include the plural and words in the masculine gender will include the feminine and neuter, and vice versa, when they should so apply.

Invalid Provisions:

The parties agree that if any provision of this Agreement is determined by a court to be illegal, invalid or unenforceable, that provision shall not be part of this Agreement. The legality, validity and enforceability of the remaining provisions shall not be affected by a determination that a provision of this Agreement is illegal, invalid or unenforceable.

Remedies, Attorney's Fees, Court Costs, Expenses, etc.:

Each party to this Agreement is entitled to enforce its rights under this Agreement specifically, to recover damages by reason of any breach of any provision of this Agreement, and to exercise all other rights in its favor. The parties agree and acknowledge that money damages may not be an adequate remedy for any breach of the provisions of this Agreement and that any party may in its sole discretion, apply to any court of competent jurisdiction for injunctive relief (including temporary restraining orders / stay away orders, temporary injunctions and permanent injunctions) in order to enforce or prevent any violation of the terms of this Agreement. The remedies of the parties under this Agreement are cumulative and will not exclude any other remedies to which any party may be lawfully entitled. Further, if any party to this Agreement files an action for breach of this Agreement, the prevailing party in such action shall be entitled to recover its reasonable attorney's fees, court costs and expenses.

This Agreement reflects the mutual understanding of the parties with respect to all subject matter addressed herein and will be construed accordingly.

Notice:

Except as expressly provided to the contrary herein, any notice required or permitted under this Agreement will be deemed sufficiently given if in writing and personally delivered, transmitted by facsimile, or sent by certified mail (postage prepaid) to the party at the address set forth beneath its signature below or at such other address as the party may subsequently designate.
